SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 2). Highly flammable liquid and vapor (H225). Keep away from heat, sparks, open flames, and hot surfaces (P210).

If exposed or concerned: Get medical advice or attention (P308+P313).

SECTION 6 — ACCIDENTAL RELEASE MEASURES

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #3. Store with hydrocarbons, oils, esters, and aldehydes. Store in a dedicated flammables cabinet. If a flammables cabinet is not available, store in Flinn Saf-Stor™ can. Keep container tightly closed (P233). Keep cool (P235). Ground or bond container and receiving equipment (P240). Take precautionary measures against static discharge (P243). Use only in a hood or in a well-ventilated area.
