Section 3 - Hazards Identification

ROUTES OF EXPOSURE: Exposure may be by INHALATION and/or SKIN or EYE contact, depending on conditions of use. To minimize exposure, follow recommendations for proper use, ventilation, and personal protective equipment.

Prolonged overexposure to solvent ingredients in Section II may cause adverse effects to the liver, urinary, cardiovascular and reproductive systems. Reports have associated repeated and prolonged overexposure to solvents with permanent brain and nervous system damage.

EFFECTS OF OVEREXPOSURE: Irritation of eyes, skin, and respiratory system. May cause nervous system depression. Extreme overexposure may result in unconsciousness and possibly death.

SIGNS AND SYMPTOMS OF OVEREXPOSURE: Headache, dizziness, nausea, and loss of coordination are indications of excessive exposure to vapors or spray mists.

Redness and itching or burning sensation may indicate eye or excessive skin exposure.

stoves, electric tools and appliances, and any other sources of ignition.
